ABSTRACT

This final project discusses the analysis of phrase linker difficulties in document writing among students majoring in English at iain metro. The purpose of this study was to analyze common and rarely used phrase linkers by fifth semester students, as well as to find out what the fifth semester students' difficulties were in doing phrase linkers in document writing.

This research method is qualitative research. The research subjects were fifth semester students of the English Department of IAIN Metro. In collecting data, researchers used observation, interviews and documentation.

The results showed that there were results from the final project (UAS) entitled the benefits of online business. Of the two sub-groups, namely intralingual errors and choosing comparative connecting phrases, there is one sub-group that is used by fifth semester students. intralingual errors reached 74%. And 26% are choosing comparative conjunctions.

CHAPTER 1

INTRODUCTION

A. BACKGROUND OF STUDY

The method of research

used by the first prior research is qualitative. The first prior research sample intralingual errors caused by faulty learning or teaching, forgetfulness or overexposure to informal use of the target language.

This research and the first prior research have similarities and differences. The similarity between this research and their research lies in the similarity of language skills and the components studied. This research and that research focus on writing skills in English and the use of linking word and phrase. The difference between both of the researches lies in the differences in the sample.

Furthermore, the second prior researchis carried out by Naomy Storch entitled"development in 12 writing after a semesterof study in an australian university"². The second prior research sample is student academic writing samples collected at the Australian university. The results of research show thatthe greatest improvements occurred in how learners structured their writingand developed their ideas.

The similarity between this research and the second prior research lies in the similarity of language skills and the components studied that are thestudents'academic writing skills in English.

The difference between both of the research lies in the differences in the sample.

Furthermore, the third prior research is carried out by Philip Shaw entitled "Linking Adverbials in Student and Professional Writing

This research and the third prior research have similarities and diffrences. The similarity between this research and the that research phrase linker in the writing skills. This research and the that esearch focus on writing skills in english. The third prior research concentrated on the use of linking adverbial phrase in writen documents. The diffrences between research and the third prior research lies in the diffrences in the descriptive qualitative research and diffrences in writing documents.

CHAPTER II

REVIEW OF LITERATURE

A. Concept of Phrase Linker

1. Definition of Phrase Linkers

Linkers are words or phrases which connect ideas, e.g. 'for', 'furthermore', 'for instance.⁴ It means that are the words that connect one sentence or idea with another. They are the ways to secure that there is a logical connection in a text.

Linkers, sometimes called linking adjuncts, are similar to conjunctions. However, instead of linking one clause to another within a sentence, they link two sentences, at the same time indicating the kind of connection there is between the two sentences.⁵ It means that linking adjuncts are used to show what sort of connection there is between one sentence with the another sentence.

Linkers or connectors that join two words, phrases, clauses or sentences together, either in speech or in writing.⁶ It means that linker or connectors are connecting sentences ore to combine words, phrase, clauses together to form a sentence that are easily understand by students both oral or written easily.

2. Function of Phrase Linkers

Linking words and phrases can help a writer to maintain flow and establish relationships between ideas'.⁷ Their taxonomy of linking words is based on 'their function and grammatical use'. For the example, distinguish: subordinators (e.g. although, even though, because), sentence connectors (e.g. furthermore, in addition, moreover) and phrase linkers (e.g. in addition to, despite, in spite of).

Distinguish linking adverbials (LAs) that perform a connecting function, showing 'the relationship between two units of discourse', which may be sentences, units larger than a sentence and also units smaller than a sentence.

Oshima and Hogue use the terms: transition signals: transition phrases (e.g. in addition, on the other hand, in contrast), conjunctive adverbs (furthermore, moreover, still, otherwise), coordinating conjunctions (and,but,yet), subordinating conjunctions (although, though, if), others (another (+ noun), an additional (+ noun), in spite of (+ noun), despite (+ noun). Other scholars also mention three groups of linking words: '(a) coordinating conjunctions, (b) subordinating conjunctions, (c) linking adverbs' (Leech, 1989:241).

Uses the term *linking words* are when describing the research on the use of 'moreover, in addition, also, besides, furthermore, what is more' in a subcorpus of Lithuanian learners of English and several British

corpuses, but she also refers to them as 'connectors' at the beginning of the paper. As the discussion above reveals, borderlines between different groups of linkers are blurred; therefore, the term *linking words and phrases* (LWPs) will be used as an umbrella term in the analysis of the selected tertiary level academic essays.

3. Type Of Phrase Linkers

In Phrase linkers, there are several types of phares linkers as follow :⁸

B. Concept of Writing

1. Nature of Writing

Writing is not only concerning about speech written down on paper but it is also the expression of ideas and meaning on the page which is relied by the writers.¹⁷ It means that writing is something that is not just the result of writing on paper but there are also aspects that are expressing ideas to be written on paper.

Furthermore, writing is not an isolated activity that merely involves writing a document, but requires a thorough understanding of the wider socio- economic context, and the ways this defines research priorities and public money allocations.¹⁸ In the other words, in the process of writing

the writers do not only look at the context and fixate on one context but must see from all broader social contexts.

Moreover, writing is its clear and logical organisation, which makes it ideal as a self-study and reference guide for students needing to work independently. This is a recognition that most courses in academic writing are inevitably time-constrained, and that some students may have no other option.¹⁹ It means that writing is something that is really needed by students so students can work independently, writing is a routine activity of students in order to store a memory into the mind.

2. Writing process

Acording to Alice Oshima Ann Hogue, there are four steps in in the process of writing, as follows:²⁰

a. Creating (Prewriting)

The first step in the writing process is to choose a topic and collect information about it. This step is often called prewriting because the writer do the step *before* the writer start writing.

b. Planning (Outlining)

In the second step, the writer chooses topics and narrowed them, and generates ideas by brainstorming. In the second step of writing process, the planning stage, the writer organizes the ideas into an outline. The writer developed three different lists of ideas:

communication problems, classroom environment, and *American family life.* As a first step toward making an outline, the teacher divides the ideas in the *communication problems* list further intosublists and cross out any items that do not belong or that are not useable.

c. Writing

The third step of writing process is writing the rough draft. Follow the writer outline as closely as possible, and don't worry about grammar, punctuation, or spelling. A rough draft is not supposed to be perfect. Above all, remember that writing is a continuous process of discovery. As the writer are writing, the writer will think of new ideas that may not be in the writerr brainstorming list or outline. The writer can add or delete ideas at any time in the writing process.

d. Polishing

The fourth and final step in the writing process is polishing what the writers have written. This step is also called revising and editing. Polishing is most successful if the writers do it in two stages. First, attack the big issues of content and organization (revising). Then work on the smaller issues of grammar and punctuation

(editing).

3. Components Of Writing

There are five general components of writing, as follows:²¹

a. Language use

Language use deals with the ability to write correct and approriate sentences. It means that writing by the rules of the language is used in the writing process.

b. Mechanical skills

Mechanical skills deal with the ability to use correctly those conventions perculiar to the written langguage –e.g punctiation, spelling. It can be said, that the author must understand the concept of interaction of writing in order to produce good quality writing.

c. Treatmenth of content

Treatmenth of content connect to the ability to think creatively and develop thoughts, excluding all irrelevant information. It means that in the process of developing ideas from a written topic requires creativity to make the quality of writing can be better.

d. Stylistic skills

Stylistic skills deal with the ability to manipulate sentences and pharagraphs, and use language effectively. It means that this skills requires the ability to use language effectively to

manipulate sentence and paragraphs to produce better sentences and paragraphs.

e. Judgement skills

Judgement skills connect to the ability to write in an appropriate manner for a particular purpose with particular audience in mind, together with an ability to select, to organize and to order relevant information. It can be said, that judgement skills related to writing skills that focuses on the objectives with what is is assessed in general.

4. Writing Assesment

The writing result should be assessed by using a writing rubric to evaluate the quality of each writing component. One of the writing rubrics is stated by J.B.Heaton that is illustrated in the following table:²²

C. Difficulties in using phrase linkers in writing

In Phrase Linkers there are some student difficulties in writing, as follow :²³

In other words, it is possible to assume that the misuse of the coordinating conjunction or may be classified as an intralingual error because the other errors in the presented sample may also be considered intralingual. Starting a sentence with a coordinating conjunction could also be a grammatical or a punctuation error, like in the following example: Ideally you should have a good

command of the language – listening ability, writing and speaking. And should be willing to improve upon these skills once found

a place. The student uses an incomplete sentence. It has to be admitted that the discussed essay demonstrated a number of errors in sentence structures, related punctuation and capitalization; thus, this is just one more example of the overall problems of the particular student's academic writing skills and intralingual errors.

In 1 cases students do not punctuate LWPs properly. For example: Also your friends or family might know people who are looking for a new workers, without putting an offer in the internet. The sentence demonstrates other grammatical errors, which may lead to a conclusion that it is the overall students' competence in English that might have affected proper punctuation after the LWP, which is another intralingual error.

 student had selected a linking phrase of comparison when discussing contrast: Secondly, the study process at the school provides with basic information about the subject.

In two case a student had selected a linking phrase of comparison when discussing contrast: Secondly, the study process at the school provides with basic information about the subject. It includes an overview of economics and introduces its biggest concerns. It includes an overview of economics and introduces about its biggest concerns. In comparison with the school, professors at the University of Latvia provide with more detailed knowledge, which helps to understand microeconomical and macroeconomical processes and allows giving a constructed opinion about discussed issues. In the following example, it can be observed that the student knows how to use the LWP properly, but the misuse of articles, word choice and an incomplete sentence in the LWP part make the sentences difficult to comprehend: Despite the low presence of graduated, most of them will have to choose an different sector of employment. On the contrary, less educated candidates might have easier access to careers such as waitress, electrician and day labourer. This example and also a number of others above justify di Gennaro's (2016) approach that it is not so important to study and analyse the quantity of errors students commit, but it is more important to consider the entire context for the errors, and in this particular case, the context makes us assume that the student is still on the way to achieving a proficient user's level.

D. How To Overcome The Difficulties In Using Phrase Linkers In Writing.

The solve of student difficulties in phrase linkers from Vineta apse and Monta farneste the solution to solve of student difficulties :²⁴

 a. Special emphasis should be placed on making students aware of the differences between the phrase linkers used in the formal and the informal register. The analysis of different types of

written texts and their register and its characteristics might be very helpful to attain this goal.

b. Additional tasks on training students' skills to distinguish between registers need to be designed, as well as lists of phrase linkers appropriate for the informal and the formal register need to be prepared. That will allow also students whose overall language proficiency is lower not to misuse phrase linkers.

CHAPTER III

RESEARCH METHOD

A. The Types and Characteristics of Research

In this case, the researcher will consider the importance of writing mastery especially phrase linkers to be explored. The researcher will decide to use qualitative research to analyze the use of phrase linkers of student writing at IAIN Metro.

According to Creswell, qualitative research is for exploring and understanding the meaning individual or group considered to social or human problem.²⁵ It can be said that qualitative research means investigate and understanding the problem of human or social by individual or groups.

Qualitative research is a research that aimed to describe, learn, and explain the phenomenon. The understanding of phenomenon can be reached by describing and exploring through narration. It means that the research procedure that result descriptive data written or spoken from the participants and the behavior that is observed. It also belongs to descriptive study that proposes to collect current information, to identify problem, to make comparison or evaluation and to learn from others' experience to establish decision.

The characteristic in this researchfocuses on the descriptive qualitative research. The researcher will take a survey that it can be used to describe

phenomena and summarize. The aim of using survey for descriptive research is getting a good step of certainthings.Descriptive qualitative analysis involves describing the common underlyingcharacteristics of data. Descriptive qualitative research is useful because it can provide important information regarding the average member of a group.²⁶

In line with the explanation above, the purpose of this research to know the use of phrase linkers of the students at IAIN Metro.

B. Data Resources

In this research the researcher divides the sources into two items. They are primary and secondary.

1. Primary sources

Primary source are original materials on which research is based. They are testimony or direct evidence concerning a topic under consideration. They present information in its original form, neither interpreted nor condensed nor evaluated by other writers. The primary source of this research is writing product of the third semester of IAIN Metro. The total numbers of the students are 20 students.

2. Secondary sources

Secondary source offers interpretation or analysis based on primary sources. They may explain primary sources and often uses them to support a specific thesis or argument or to persuade the reader to accept a certain point of view. The secondary source in this research is from interview,

documentation, journals, e-books and articles that are related to the research.

C. Data Collecting Technique

Qualitative research typically follows an inductive process.²⁷It means that the data collection taken from process analyzing data become theory or interpretations. Creswell said that "in many qualitative studies, inquiries collect multiple forms of data and send a considerable time in the natural setting gathering information"²⁸.The data collection is the accumulation of specific evidence that will enable the researcher to properly analyse the results of all activities by his research design and procedures.

The data are needed in a research work to serve the raw material that is used in the production of data. It provides a definite direction and definite answer to a research inquiry. Whatever inquiry has to give a definite answer to an investigation. Data are very essential for a scientific research. In addition, the data are needed to substantiate the various arguments inresearch findings.²⁹

Qualitative researchers also have a toolbox of data-gathering techniques, including indepth interviewing, participant observation, and document analysis.³⁰ The researcher in this research uses document to collect the data. The researcher takes documents from the result of the use of phrase

linkersw in students' phrase linkers. In the process of collecting the data, the researcher collects the results of writing students to analyze and to identify the using of writing in phrase linkers.

In this research, the researcher use three techniques to collect the data. There are observation, documentation and interview

1. Observation

Observation is the process of gathering open-ended, firsthand information by observing people and places at a research site.³¹ As a form of data collection, observation has both advantages and disadvantages. Advantages include the opportunity to record information as it occurs in a setting, to study actual behavior, and to study individuals who ave difficulty verbalizing their ideas (e.g., preschool children). Some of the disadvantages of observations are that you will be limited to those sites and situations where you can gain access, and in those sites, you may have difficulty developing rapport with individuals. This can occur if the individuals are unaccustomed to formal research (e.g., a nonuniversity setting).

2. Documentation

Qualitative researcher may use written documents or other artifacts to gain an understanding of the phenomenon under study.³²In this research, the researcher uses documents technique to collect the data. Documents

can be a valuable source of information in qualitative research. Creswell cited that documents represent public and private documents. Public documents provide in the form of minutes from meeting, official memos, and newspaper. Example of private documents is personal journal and diaries, letters, and personal notes.³³ Accordingly, the secondary data needed are documented as data resource in the form of documentation. Furthermore, the researcher got the data form the result of students' writing document.

3. Interview

Interview is a purposeful dialogue. The aim of interview is to gain on going something about the people, occurrence, activity, organization, feeling, motivation, etc. Something ongoing based on the past experience. The condition is probably occurring in the future to verify and developing the last information.³⁴ The researcher will interview five or eight students of the third semester students of IAIN Metro, what are the students' difficulties in using phrase linkers in writing skill among the English department students at IAIN Metro in the academic year of 2020/2021. In interview the researcher conducted face-to-face interview with participants, interview with five or eight students at the third semester at IAIN Metro.

D. Data Analysis Technique

The important part in research study is analyzing data, because the result becomes a conclusion from all of the research. Analysis of data means studying the tabulated material in order to determine character facts or meanings.It involves breaking down existing complex factors into simple parts and putting the parts together innew arrangements for the purpose of interpretation. Qualitative data generally take the form of words (descriptions, observations, impressions, recordings, and the like). The researcher must organize and categorize or code the large mass of data so that they can be described and interpreted. In qualitative research, data analysis includes of two aspects, the aspects consists of text analysis and involve developing a description and themes.

The researcher would apply Miles and Huberman model to analyze the data.³⁵ The componets of this analysis model are pictured by this figure.




Figure II. Analysis Components of Miles and Huberman Model

Data analysis by Miles and Huberman model conducts the following steps:³⁶

- Data collection is the step when the researcher gather all data which are used to complete the research.
- The researcher reduces the data he had gotten by summarizing and choosing specific things.
- 3) To display the data, the researcher usually uses graphics, figures, or charts. The display should be able to describe the content entire the data.
- Lastly, the researcher verifies his research by making conclusion of data findings.

Therefore, it is concluded that the analysis of data has somefunctions in analyze research data that include in; to make the meaningfulraw data, to test null hypothesis, to get the significant results, to describe inferences or to make generalization, and to calculate parameters.

E. Research Approach

- In this research the researcher use six steps in the process of research, as follows:³⁷
 - 1. Identifying a Research Problem

Writer begins a research study by identifying a topic to study typically an issue or problem in education that needs to be resolved. Identifying a research problem consists of specifying an issue to study, developing a justification for studying it, and suggesting the importance of the study for select audiences that will read the report.

2. Reviewing the Literature

Skills required for reviewing the literature develop over time and with practice. The writer can learn how to locate journal articles and books in an academic library, access computerized databases, choose and evaluate the quality of research on your topic, and summarize it in a review. Library resources can be overwhelming, so having a strategy for searching the literature and the review is important.

3. Specifying a Purpose for Research

If the research problem covers a broad topic of concern, writer needs to focus it so that writer can study it. A focused restatement of the problem is the *purpose statement*. This statement conveys the overall objective or intent of the research. As such, it is the most important statement in your research study.

4. Collecting Data

Evidence helps provide answers to the research questions and hypotheses. To get these answers, the writer engages in the step of collecting or gathering data. Collecting data means identifying and selecting individuals for a study, obtaining their permission to study them, and gathering information by asking people questions or observing their behaviors.

5. Analyzing and Interpreting the Data

During or immediately after data collection, the writer needs to make sense of the information supplied by individuals in the study. Analysis consists of "taking the data apart" to determine individual responses and then "putting it together" to summarize it.

6. Reporting and Evaluating Research

After conducting the research, the writer will develop a written report and distribute it to select audiences (such as fellow teachers, administrators, parents, students) that can use the information.

CHAPTER IV

RESULT AND DISCUSSION

A. Description of Research Location

1. Profile of State Istitute for Islamic Studies of Metro

a. The Historical Background of IAIN Metro

IAIN Metro is located in Metro city, Lampung province. IAIN Metro is the only one the State Institute for Islamic Studies in this city. IAIN Metro is change of status from STAIN Jurai Siwo Metro. It is dedicated in 2017 based on the decision of Presidents No. 71 on 1 August 2016. IAIN prepared this change since 2010. From 2011, STAIN Jurai Siwo Metro continued to strive for the development of STAIN Jurai Siwo Metro to be IAIN Metro.

STAIN Jurai Siwo Metro was establish on April 23-25, 1997 based on the explanation letter of president RI No. 11 in the year 1997. The establishment of STAIN Jurai Siwo Metro cannot be separable with the history of IAIN Raden Intan Bandar lampung. The existence of IAIN Raden Intan Bandar lampung began from the effort of elite and religion figures that were joined together in Lampung Islamic Welfare Foundation (YKIL). In the discussion of YKIL, it was dealt to accomplish two faculties, Education faculty and Islamic Law faculty, which were domiciled in Tanjung Karang. Through the persistent strunggle of YKIL, on 13 October 1964 the status of islamic Law faculty was changed from private to state. Referring to the decision of Indonesian President No. 27, 1963, in order to accomplish Al-Jami'ah, YKIL should at least have three faculties. For that reason, YKIL opened Ushuludin Faculty that is domiciled in Tanjung Karang in 1965. As an effort to realize the founding of STAIN Al-Jami'ah in Lampung, the first step was to make state-owned all Faculties which were still in private status at that time. Finally, it realized the dream of Lampung society to found STAIN Al-Jami'ah based on the Decree of Minister of Religious Affair of RI No. 187/68 which was named " State Islamic Institute Raden Intan Tanjung Karang". In the year 1993 based on the change of the name of capital province of lampung from Tanjung Karang to Bandar Lampung, STAIN Raden Intan Tanjung Karang was also changed to STAIN Raden Intan Bandar Lampung.


Likewise, in 1967, the education and Islamic Law Faculty were established in Metro. It was not far from the change of name STAIN Raden Intan Tanjung Karang to STAIN Raden Intan Bandar Lampung that it went out a handbill of Director General of Bimas Islam No. E.III/OT.00/AZ/1804/1996 on August 1, 1996 about Settlement of Institutional Faculties STAIN outside centaral institute to be Sekolah Tinggi Agama Islam Negeri (STAIN). That was the history of the establishment of STAIN Jurai Siwo Metro. This state now campus buildings that are located at Jl. Ki Hajar Dewantara Street 15 A, East Metro for campus 1 and at Ki Hajar Dewantara Street, Banjar Rejo, Batanghari, East Lampung for campus 2. As a State, IAIN Metro was founded to graduate students who have quality not only on developing Islamic value and but also science. It was described in is vision: "To be Islamic State". Then, to accompish the vision, IAIN Metro composed some missions, namely (1) Developing three pillars of university (education, research and development, and society services), (2) Developing and spreading and technology in Islamic culture, and creating academic persons who are smart, competent, and have good morality.

Nowadays, IAIN Metro has four faculties namely Tarbiyah and Teacher Training Faculty, Syari'ah Faculty, Economic Business Faculty, and Islamic Announcement and Communication Faculty. 



2. The solution to overcome the students' difficulties in using phrase linkers in students writing


